He received a BA in German language and literature from Seoul National University, Korea, in 1967, and an MS and PhD in business administration from the University of Illinois in 1974. Professor Park coauthored Marketing Management (Dryden Press, 1987) with Dr. Gerald Zaltman of Harvard University, and Handbook of Brand Relationships (M.E. Sharpe, 2009) with Deborah J. MacInnis and Joseph Priester. In 1987 he was the recipient of the Alpha Kappa Psi award for his article Strategic Brand Concept-Image Management, which appeared in the Journal of Marketing. He is a fellow of the Society of Consumer Psychology (2012) and the Association for Consumer Research (2015). Dr. Park is a former editor of the Journal of Consumer Psychology (2008-2012). He currently serves as director of the Global Branding Center, Marshall School of Business, University of Southern California (2008-present). Dr. Park served as an advisor to Samsung from 1989 to 1998 and as a member of the board of directors for Samsung Corporation from 2001 to 2010. He has been an advisor for Pulmuone Corporation since 1993. He has been directing and teaching a number of marketing executive programs at Marshall since 1998.

Dr. Deborah J. MacInnis is the Charles L. and Ramona I. Hilliard Professor of Business Administration and a professor of marketing at the Marshall School of Business, University of Southern California.
